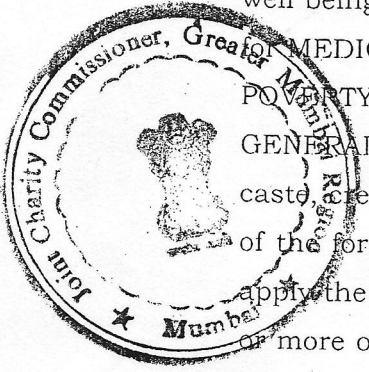

3. OBJECT OF THE TRUST



The aim, objects and purposes of the trust are public charitable in nature. This includes initially the promotion and well being of the needy, poor and deserving people by providing MEDICAL, RESEARCH, SECULAR EDUCATION, RELIEF OF POVERTY OR DISTRESS AND ANY OTHER OBJECT OF GENERAL PUBLIC UTILITY, without any discrimination to caste, creed, religion or sex. Without prejudice to the generality of the foregoing aims, objects and purposes, the trustees may apply the Trust fund or any part thereof in or towards any one or more of the following objects in such manner in all respects as the Trustees may in their discretion deem fit and proper.

- i. To provide medical relief.
 This includes :-
 - a. Establishing, maintaining and supporting institutions such as hospitals, dispensaries, laboratories, health units, clinics, maternity homes, child care centers, sanatoriums and the like;
 - b. Aiding and assisting maternity cases;
 - c. Taking care of the mother and child during the parental and postnatal period;
 - d. Organizing and sponsoring health camps for women and children;
 - e. Taking care of infants; and

- f. Aiding and assisting convalescing persons and providing for their transport and accommodation among other things.
- g. To undertake such endeavors as are incidental and conducive to the attainment of the medical objects of the trust.
- ii. To promote, establish, maintain and run a medical research or centers at any suitable place or places in India.
- iii. To bring advances in health care and medicine to the door step of rural and tribal regions of India, which is ethical, dependable, modern and affordable.
- iv. To emphasize preventive health care issues and promote maintenance of good health as defined by WHO.
- To work in coordinated way with other basic development issues of public health and public utilities, education and economical upliftment in the region.
- vi. To give medical help to the poor and to provide ambulance and healthcare facilities without distinction o grounds of caste or creed.
- To give financial help to the needy widows and orphans belonging to all castes for the purpose of their maintenance, medical treatment and education, specially in arts and crafts so as to enable them to earn their livelihood.
- viii. To encourage and advance learning and spreading of secular education amongst the poor, needy and deserving boys and girls irrespective of caste, creed or religion by giving them aid in the form of school scholarship, interest free loans and supply them books free of cost.
- ix. To create and forge fraternity amongst the people irrespective of caste, creed or religion by holding socio-cultural get-together, peace rallies, lectures, seminars, debates elocutions and such other means



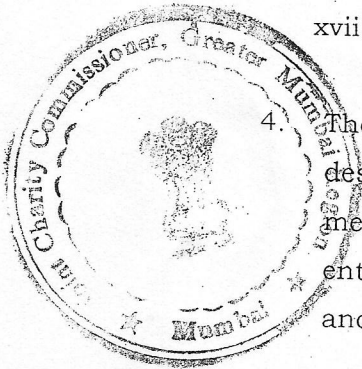








- x. To undertake such endeavors as are incidental and conducive to the attainment of the objectives and/or purpose of the Trust.

- xvii. To conduct the body building championship.

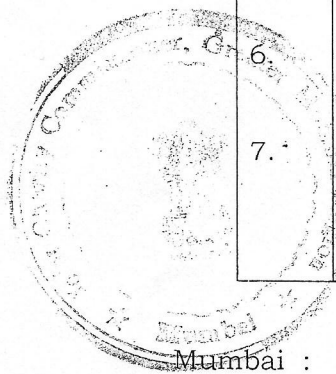




